- VIII. Purchases:
 - a. A Regular Meeting motion is requested by the police department to approve and award the bid to the lowest responsive bidder, Dillard Door and Entrance Controls of Memphis, TN, for the installation of security doors and access control system at the police department building. The total cost is \$29,836.28 and includes the base bid and additive alternate #1. **MICHAEL PITTS**
 - b. A Regular Meeting motion is requested by the police department to approve and award the bid to the lowest responsive bidder, JusticeOne of Acworth, GA, for the provision of a cloud-based law enforcement records, citation, and courts management solution. The total contracted amount is \$36,000 per year for a 3-year commitment and is included in FY26. **MICHAEL PITTS**
 - c. A Regular Meeting motion is requested by the police department approving a contract expansion with Axon Enterprise, Inc for the provision of 10 additional dash camera units with installation. The total contract expansion

price is \$33,899.78 per year for the remaining 3 years of the existing contract. This expansion is made under TN state contract #82619 and was budgeted in FY26. **MICHAEL PITTS**
