All registrants must abide by the rules set forth by the City of Savannah and the Savannah Rotary Club Committee. These rules are as follows:

1. No off road vehicles, ATVs, dune buggies, or motorcycles.
2. No horseback riding allowed only pulled wagons, carriages, or horse drawn transport with brakes.
3. For safety issues, no candy or other items may be thrown from a vehicle or float, but should be handed/distributed by people walking along side your entry in the parade.
4. All vehicles must be decorated and be a valid entry. Commercial entries are welcome, but must provide entertainment value.
5. Drivers must be at least 18 years of age.
6. All vehicles must maintain a safe speed. Fast acceleration of vehicles is not allowed. Please maintain a safe distance between your entry and the entry ahead of you at all times.
7. All parade entries must have a signed (by the responsible person) Parade waiver form attached to your registration form.
8. All entries will be contacted & given a line-up number. Line-up begins at 9am, parade begins at 10am.
9. The sponsors reserve the right to refuse any participant or remove any participant for not abiding by the guidelines set forth for the parade.
